Briefly describe the process which lead you to discern the call to the office bishop.

I was baptized, confirmed, married, and ordained in the UMC. This is my church - warts and all. Because the UMC means so much to me, I am more than willing to serve it in whatever way God has called and equipped me. This call was recently affirmed, as I was endorsed by my annual conference. My God-given gifts seem to center around leadership, communication, and administration. Since our church is in dire need of spirit-led leaders who possess those particular skills/talents, I feel compelled to answer the call to the episcopacy for such a time as this. "Here I am, Lord. Send me." During my 7 years on the Appointment Cabinet, I have served under 5 different bishops! The varied leadership, management, and appointment styles of each of those episcopal leaders has provided me with a rather unique experience from which to draw. I hope to incorporate the best of each of them.

• The Role of the Bishop in The United Methodist Church is delineated in paragraph 403 of The Book of Discipline. After reading this paragraph, please share how you are called and equipped to fulfill the responsibilities. Please elaborate on ¶ 403.1 and e-f.

One way to guard the faith, order, liturgy, doctrine, and discipline of the UMC is to prayerfully hold each clergyperson in the annual conference accountable to the standard of pastoral excellence (not mere competence). Consequently, our connectional covenant is not only kept, but strengthened. Because the UMC has been "family" for me for my entire life, I pray and endeavor to keep it together – not for the preservation of the institution but for the sake of family unity. I am committed to our connection. When I attended the last World Methodist Conference in South Africa, I was struck by how well the once-segregated citizens of that country seemed to work, worship, and play together in peace and harmony. It seems to me that if the people of post-Apartheid South Africa can do it, the people of the post-modern UMC can do it too. I have taken 3 primary vows in my life. – when I was commissioned as an officer in the US Navy, when I was married to Karen, and when I was ordained in the UMC. I have kept each of those vows inviolate for 30 plus years, and I hope that everyone else can and will do the same.

• How would you as a new bishop collaborate with your colleagues on the College of Bishops to be spiritual and missional leaders for the whole jurisdiction so that NEJ better fulfills the mission and ministry of Christ Jesus?

3 words – Imagine No Malaria. I expect that as a new bishop, I would do what one bishop in the NEJ did a couple years ago when he visited our Cabinet Room and inspired and invited our annual conference to accept the challenge to Imagine No Malaria. Because of this collaborative effort, our conference engaged in some significant second-mile giving by raising hundreds of thousands of additional dollars to help save tens of thousands of children's lives. Episcopal collaboration at its best!

 How would you as a new bishop share the good news of Christ Jesus inviting, engaging, connecting with persons in your assigned area who are not currently active in a faith community so that you might become a leader and model for making disciples?

My late father was a fisherman – and a good one at that. His secret for success? "Go to where the fish are." As a bishop, I will go to where the fish are, and ask my clergy and laity to do the same. I will use my experience in radio, TV, newspaper, and blogging to establish and maintain a UMC presence in both traditional and social media in order to better fulfill Jesus' mandate to be fishers of all people.

Describe how you would equip the United Methodists of your area for ministry and evangelism in our culture context?

I call it "relevangelism" - making disciples by first making the UMC relevant to the unchurched. Thanks to our perceived irrelevance, the mission field has never been larger. Thanks to Facebook and Twitter and the like, reaching the mission field has never been easier. John Wesley would be envious!
